In consideration of Lappin Foundation accepting Applicant and Applicant's Parent(s) into 2018 Robert I. Lappin Youth to Israel Adventure (Y2I) and because the Applicant is receiving a subsidy from Lappin Foundation, the undersigned Applicant and Applicant's Parent/Guardian(s) agree as follows:

1. Attendance at all required meetings in accordance with the schedule provided. Lappin Foundation reserves the right to change dates, times and locations of any of the meetings. Failure to attend required meetings will result in forfeiture of the \$500 refundable deposit, which will not be considered a tax-deductible donation.
2. Upon return from Israel, the applicant is required to write a reflective essay about what the Israel trip meant, and attend the post-trip event. Failure to complete the post-trip requirements will result in forfeiture of the \$500 refundable deposit, which will not be a tax-deductible donation.
3. A personal interview of applicant and possibly applicant's parent(s) is required as a pre-requisite to final acceptance into the program.
4. Withdrawal from 2018 Y2I by the applicant or applicant's parent/guardian(s) may result in the applicant and/or applicant's parent/guardian(s) repaying costs incurred by the Lappin Foundation and loss of any deposits in accordance with the cancellation policy set forth in the **Cancellation and Reimbursement Policies** form. The deposit will be credited toward such losses.
